3. Only entries submitted that meets the stipulated requirements i.e. Proposer and Nomination for APQO International Individual Award and Specific Award Nomination Form will be accepted and assessed.
4. All entries submitted will become the property of the APQO Awards Committee and APQO & GPEA Secretariat.
5. All nominations submitted will not be returned to the proposer unless a separate arrangement has been made prior the submission of application.
6. Entrants should not disclose any confidential/classified or price-sensitive information, as the confidentiality of such information cannot be guaranteed
7. Applications are open only to nominations supported by APQO organizations/by APQO Board or APQO CC members
8. Decision of AIIA Judging Panel is final. No communication will be entered into after the selection of the winners. APQO Secretariat via its appointed Panel of Judges reserves the right to determine the winners at its sole discretion and is not obliged to divulge any judging related information.
9. The granting of any APQO Award to an individual is subjected to the nominee attending the awards ceremony in person.
10. APQO/GPEA Secretariat reserves the right to withdraw an award from an applicant/entrant in the case of non-attendance or any undesired/unlawful conduct.
11. The cost towards attending the award ceremony is to be borne by the organization or award winner and any of his accompanying party.
