### APQO - AIIA Terms and Conditions

1. Entries submitted after the **announced deadline will not be accepted**
2. APQO Member Organizations may support as many entries & categories. Each entry must be submitted with one proposer form ticked for one award category.
3. Only entries/ applications submitted that meets the stipulated criteria e.g. **Proposer of Nomination for APQO International Individual Award and Specific Award Nomination Form** will be accepted for judging and or consideration.
4. All entries/applications will become and remain the property of the APQO Awards Committee and APQO Secretariat. The APQO Secretariat in managing the process will not return submissions to the applicant / entrant unless a separate arrangement has been made prior the submission of application.
5. Entrants should not disclose any confidential/ classified or price-sensitive information in the application, as the confidentiality of such information cannot be guaranteed
6. Application / Entry is open only to organisations /individuals supported / sponsored by APQO Core Council Members and are from countries of the CC members or are linked to APQO
7. The decision of the AIIA Judging Panel is final. No communication/correspondence will be entered into the selection of the winners. VP Awards and APQO Secretariat via its appointed Panel of Judges reserves the right to determine the winners at its sole discretion, and is not obliged to divulge any judging related information.
8. The granting of any APQO Award to an individual **is subjected to the nominee attending the awards ceremony in person.**
- 9) APQO Secretariat reserves the right to withdraw an award from an applicant / entrant in the case of non-attendance.
- 10) The cost towards attending the AIIA award Ceremony is to be borne by the AIIA award winner and also for any of his/her accompanying party.
